The reforms to Medicare in the last few years are fully covered, and the coverage of Medicaid has been rewritten to make it clearer. The authors have updated and added statistics that illuminate what life is like for older Americans and have expanded the ""Questions"" that will stimulate students to think carefully about the policies that underlie elder law.
